### RESOLUTION APPROVING SALARY SCHEDULES AND WAGE ADJUSTMENTS

**WHEREAS**, the Illinois Public Employee Labor Relations Act (5 ILCS 315/1 et seq.) has established regulations regarding collective bargaining with a union; and

**WHEREAS**, the Salary Schedules and wage adjustments for the period of December 1, 2008 through November 30, 2012 have been negotiated between the Cook County State's Attorney and the Fraternal Order of Police (FOP) representing twenty-seven (27) State's Attorney Investigators' Supervisors; and

**WHEREAS**, the general increases and wage adjustments that have been negotiated are reflected in the Salary Schedules and are included in the Collective Bargaining Agreement negotiated between the Cook County State's Attorney and the Fraternal Order of Police (FOP) representing the State's Attorney Investigators' Supervisors; and

**NOW THEREFORE BE IT RESOLVED**, that the Cook County Board of Commissioners does hereby approve the Salary Schedules and wage adjustments negotiated between the Cook County State's Attorney and the Fraternal Order of Police (FOP) representing the State's Attorney Investigators' Supervisors; and

**BE IT FURTHER RESOLVED**, that the Chief of the Bureau of Human Resources and the Cook County Comptroller are hereby authorized to implement the Salary Schedules and wage adjustments as negotiated.
