09 WC 50129



Vice Chairman Reyes, seconded by Commissioner Tobolski moved Approval. The motion carried.


Vice Chairman Reyes seconded by Commissioner Garcia, moved to adjourn. The motion carried unanimously and the meeting was adjourned.
