The Petitioner tripped on a broken, uneven surface and fell to the ground, injuring her left knee.

The Petitioner sustained injuries to her left ring finger when a patient she was transporting violently grabbed and squeezed her hand.

The Petitioner sustained injuries to her left shoulder when a patient fell on top of her.

01 WC 19942

The Petitioner sustained a back and left shoulder injury while she was attempting to reposition a patient by pulling and lifting the patient who was lying in a bed.

03 WC 04832

The Petitioner injured her back and left shoulder while assisting a patient who was trying to stand up.

03 WC 27941

The Petitioner was changing linens when a heavy patient rolled over on her right hand and wrist.

03 WC 27940

The Petitioner sustained an injury to her left shoulder while she was lifting and reaching for patient supplies.
