**CAMPAIGN TO EDUCATE COUNTY EMPLOYEES ON THE  
SEVERITY OF WORKERS' COMPENSATION FRAUD**

**WHEREAS**, worker's compensation benefits are a form of insurance providing wage replacement and medical benefits to employees injured in the course of their employment; and

**WHEREAS**, there are many legitimate worker's compensation cases, but still, millions of dollars are spent every year, at all levels of government, to pay out fraudulent cases of worker's compensation; and

**WHEREAS**, Cook County has spent, on average, \$20 million a year on worker's compensation cases; and

**WHEREAS**, the Worker's Compensation Division of the Cook County State's Attorney's Office defends cases before the Industrial Claims Commission that are believed to be non-compensable; and

**WHEREAS**, in light of the recent articles and news stories, including the story of one (1) person that allegedly referred to himself as the "duty injury king" and the burden it places on the tax payers of Cook County, the County needs to educate employees on the seriousness of such claims; and

**WHEREAS**, employees that boast about filing fraudulent worker's compensation, may not understand the severity of the penalties for such fraudulent claims; and

**WHEREAS**, the penalties for workers compensation fraud, as laid out in 820 ILCS 305/25.5 can range from a Class A misdemeanor to a Class 1 felony, depending on the amount of money involved in the fraud; and

**WHEREAS**, an awareness campaign, educating employees on the severity of the penalties for such fraud, should deter employees from filing fraudulent worker's compensation claims, potentially saving the County millions of dollars.

**NOW, THEREFORE, BE IT RESOLVED**, that the Cook County Board of Commissioners does hereby request that the Department of Risk Management, the Office of the Cook County State's Attorney and the Office of the Inspector General work together on an awareness campaign, educating Cook County employees on the severity of fraudulent worker's compensation claims and the possible penalties associated with such claims.

**CAMPAIGN TO EDUCATE COUNTY EMPLOYEES ON THE SEVERITY OF  
WORKERS' COMPENSATION FRAUD**

**WHEREAS**, workers' compensation benefits are a form of insurance providing wage replacement and medical benefits to employees injured in the course of their employment; and

**WHEREAS**, there are many legitimate workers' compensation cases, but some individuals, across all levels of government and in the private sector, seek to take advantage of the system by pursuing fraudulent workers' compensation claims at significant expense; and

**WHEREAS**, Cook County has spent, on average, \$20 million a year on workers' compensation cases; and

**WHEREAS**, the Workers' Compensation Division of the Cook County State's Attorney's Office defends cases before the Illinois Workers' Compensation Commission; and

**WHEREAS**, in light of the recent articles and news stories, including the story of one person that allegedly referred to himself as the "duty injury king," and the burden it places on the taxpayers of Cook County, the County needs to educate employees on the seriousness of such claims; and

**WHEREAS**, employees who engage in fraudulent workers' compensation claim activity expose themselves to severe penalties for such fraudulent claims; and

**WHEREAS**, the penalties for workers compensation fraud, as laid out in 820 ILCS 305/25.5 can range from a Class A misdemeanor to a Class 1 felony, depending on the amount of money involved in the fraud; and

**WHEREAS**, an awareness campaign to educate employees on the severity of the penalties for such fraud should deter employees from filing fraudulent workers' compensation claims, potentially saving the County millions of dollars over time.

**NOW, THEREFORE, BE IT RESOLVED**, that the Cook County Board of Commissioners does hereby request that the Department of Risk Management, the Office of the Cook County State's Attorney and the Office of the Inspector General work together on an awareness campaign to educate Cook County employees on the severity of fraudulent worker's compensation claims and the possible penalties associated with such claims.

The Petitioner slipped on ice in the employee parking lot and fell, injuring her left hand.

The Petitioner slipped on water in the hallway and fell injuring her left wrist.

While trying to break up an altercation the Petitioner fell to the floor, hitting his right knee and back on a bench.
