While driving a trim mower, a weld on the frame broke making the control arm come down on petitioner's right knee and throwing him backward onto his neck and left shoulder.

Commissioner Tobolski, seconded by Vice Chairman Reyes, moved to concur with the recommendation of the Legal Department. The motion carried.

**2. Andy Kraly vs. Forest Preserve District of Cook County,
Case No. 12 WC 40591**

1. \$667.46 in TTD from 2/4/12 thru 2/10/12
2. Any unpaid TTD which accrued from 2/1/12 thru 5/20/13
3. District to be credited \$1,401.88 for TTD
4. District to authorize arthroscopic surgery of right knee
5. No penalties/fees imposed on District

Petitioner tripped and fell while stepping from parking lot up to the curb and sidewalk.

Commissioner Tobolski, seconded by Vice Chairman Reyes, moved to concur with the recommendation of the Legal Department. The motion carried.


**3. Christopher Roy vs. Forest Preserve District of Cook County,
